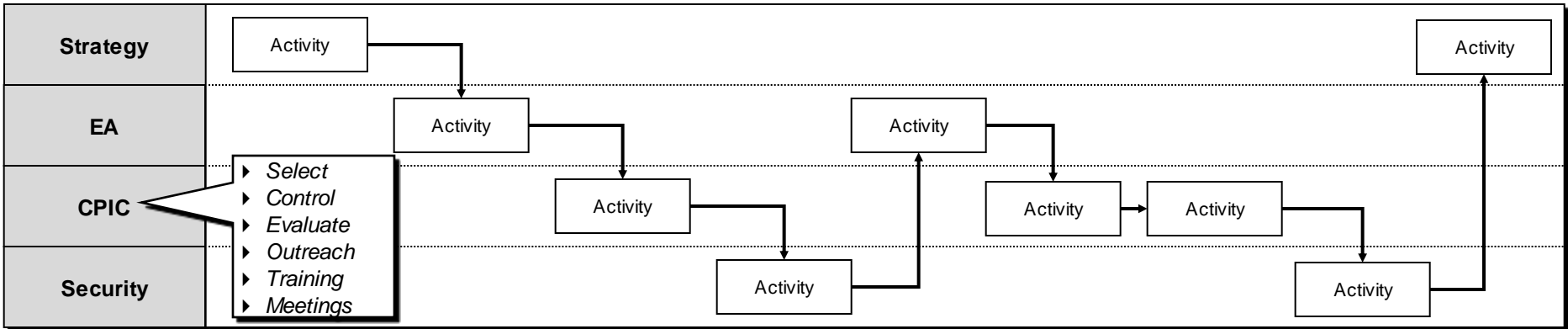


# Oxford Roadmaps and Deployment Models

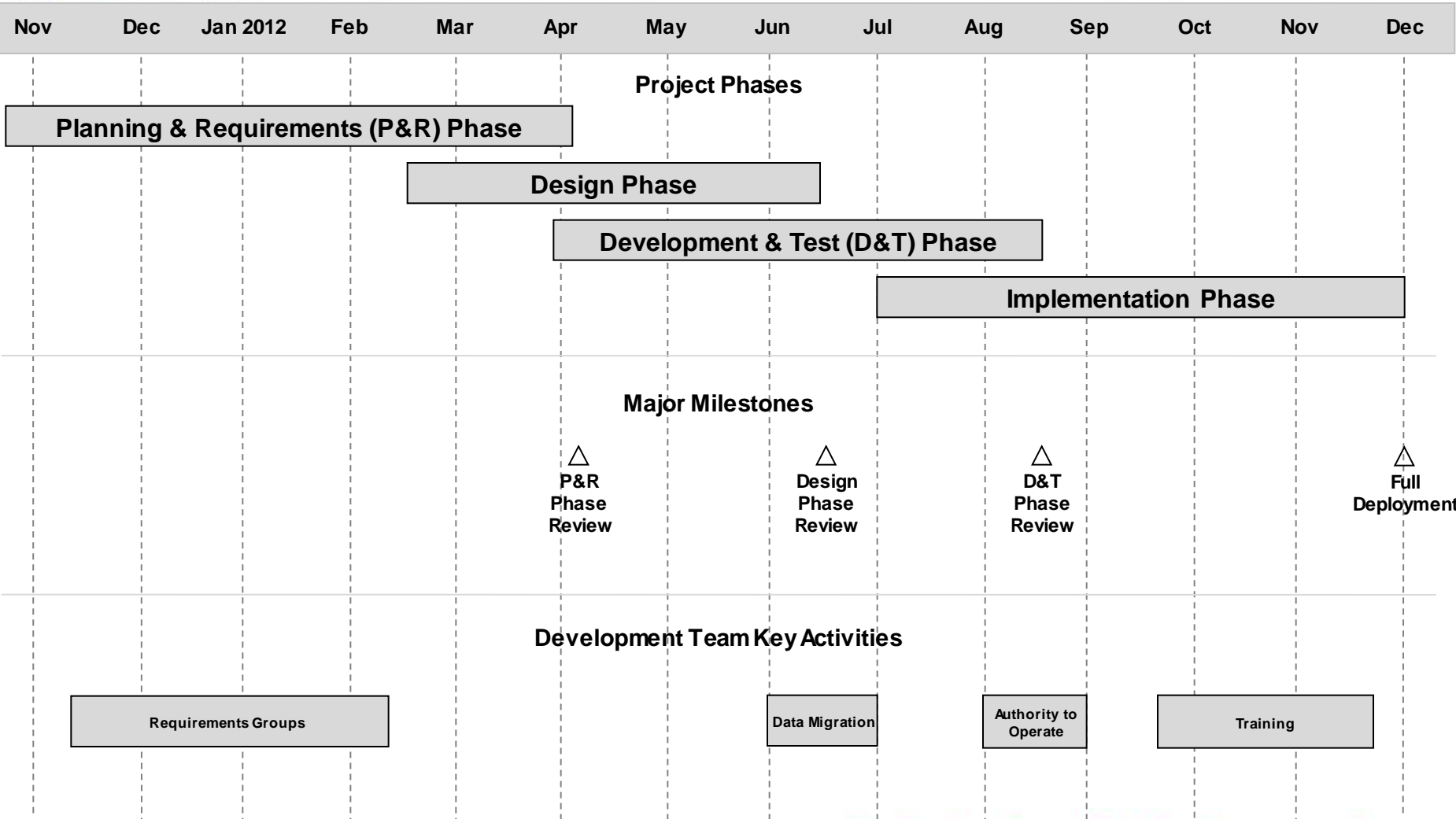
